Meeting: 1:30 p.m. first and third Wednesdays of each month, One Technology Center, 175 E. 2nd, Tulsa City Council Chamber, 2nd Level, Tulsa, Oklahoma (unless otherwise specified herein). Cutoff dates for MPD, CO, PUD Minor Amendments are 21 days prior to the TMAPC meeting. Cutoff dates for County PUD Detail Site Plans are 14 days prior to the TMAPC meeting. When not submitted concurrent with a rezoning request, Optional Development Plans must be submitted at least 21 days prior to the TMAPC meeting. Staff will determine schedule for Special Area Overlay applications as they are submitted.

Technical Advisory Committee (TAC)

Meeting: 1:30 p.m., first and third Thursday, at INCOG offices located on the 8th Floor, 2 West 2nd St., Tulsa, Oklahoma (unless otherwise specified herein). Cutoff dates are for submittal of subdivision plats, lot-splits, lot-combinations, and plat waivers. TAC reviews such requests prior to the Planning Commission (TMAPC) meeting.

Planning Review Committee (PRC)

Meeting: Immediately following TAC meeting, first and third Thursday, at INCOG offices located on the 8th Floor, 2 West 2nd St., Tulsa, Oklahoma (unless otherwise specified herein). Cutoff dates are for submittal of new MPD's, Corridor Development Plans, County PUD's, and their respective Major Amendments, as well as PUD Major Amendments and Comprehensive Plan Amendments. PRC reviews such requests prior to the Planning Commission (TMAPC) meeting.
